The figures of the leasing industry in Brazil totaled R\$ 86.31 billion in 2010 -, but are still well below market potential. In a year in which the Brazilian economy grew 7.8%, the amount new businesses accumulated during the year amounted to R\$ 26.46 billion.

The space for growing the leasing operations- especially with legal entities- is large, and we already noted the increase of immobilization in the areas related to the production segments.

The representativeness in the machinery and equipment industry jumped from 10.3%, in 2010, to 14.94%, in 2011. In the IT industry, relative growth was even bigger: the fixed assets' figures for IT equipment leasing grew from 1.28% to 4.77%. In addition, the participation of their assets accounts grew from 2.62% to 3.31% of the total portfolio. On the other hand, there was reduction in the participation of some assets, such as vehicles, whose portfolio participation was reduced from 85.80% in April 2010 to 76.98% in April 2011. The leasing of vehicles was very much affected by the reduction of the Tax on Financial Operations during the international crisis of 2008, which aimed at keeping the employment level and production of the automotive industry, with consequent migration to direct financing operations.

The changes in the dynamics of the domestic portfolio demonstrate leasing guidance for the production segment, which makes the growth perspective prevail in terms of leasing utilization, even before the results being achieved for this date.

In the current economic scenario, with a large drive of productivity, we can observe an increasing need for using machinery, equipment and vehicles, which are potentially reflected in the growth of leasing agreements.

On the other hand, the infrastructure works associated with the Growth Acceleration Programs (PAC I and II) must be highlighted, established by the Brazilian Federal Government, and preparations for the 2014 World Cup e and 2016 Olympic Games , which had already boosted the machines, equipment, IT, trucks and vehicles markets in general.

Based on the above considerations , and since leasing is already a product disseminated in the structure of the Brazilian financial system, in addition to enabling easy operation for contracting, we believe in the major role for contributing to the modernization of the Brazilian industrial park, releasing the companies and associations from the utilization of their own funds.
